- ▶ The entire SHARPSGUARD® range comes with colour-coded lids and labels for ease of appropriate segregation and consignment; leading to good waste management and compliance with best practice and the current regulations

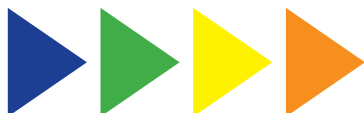
